



Dear CB community:

When Lori Laughlin and Felicity Huffman were the first of what became several dozen celebrities and other wealthy families accused of using bribery and fraud to get their kids into college, I thought it would be lost to the relentless news cycle within days.

I was wrong, and happy to be so. This scandal validated College Bound students' experiences publicly and irrefutably: College admission is one of many processes that is not designed for people who are the first in their families to navigate it and/or do not come from financial means. It can be bought legitimately and illegally. College access is something to which many feel entitled despite having little interest in furthering their education.

This clear evidence of a rigged system came as the student debt crisis (\$1.6 trillion and growing) continues to escalate. In 2016, College Bound's Board of Directors decided to set a goal around student debt for the first time. While we are striving to ensure that no College Bound student graduates with more than \$35,000 in debt, the super-wealthy are spending ten times that to pay off admissions staff and falsify their kids' athletic records.

Yet it is **our students** who are made to feel as though they don't belong at their universities, sometimes to the point where they question it themselves. This is why your support matters. By showing up for our students in the many ways you do, you show our students there is a community out there that believes in their worthiness, their gifts, and their potential.

Seeing students who once questioned their abilities grow into proud, confident young adults is a humbling privilege. I hope you are proud to be a part of that process. When we say "We are CB," you are part of our "we." Thank you for being there and for all you do.



WE ARE CB

Through an individualized, holistic, and multi-year commitment, CB empowers promising students from economically disadvantaged backgrounds to achieve bachelor's degrees and successful careers.

OUR STUDENTS

This school year, CB's full-service program reached 600+ students, plus 130 students via St. Louis Community College. Our high school students attend 44 high local schools; college students attend 70 colleges and universities nationwide. Of these students:

89%

qualify for federal free & reduced lunch program

90%

will be the first in their families with a college degree 100%

are committed to obtaining their college degree (we measure this)

A typical College Bound student earns a high school GPA of 2.5 or higher, spends summer working on college coursework, raises their ACT score by 2 points, applies for fly-in scholarships, goes on 2 college campus visits, goes to camp for the first time, focuses on career path planning, navigates financial aid and travels to CB for class and extra tutoring.

NORTH STAR GOALS

- 65% will earn a bachelor's degree within five years of high school graduation so that they are in a position to pursue a career path or enroll in a postgraduate program.
- No CB student will have more than \$35,000 in debt when they receive their baccalaureate degree.

INTENTION & PURPOSE

whatwedo

Our 7-9 year program starts in high school and lasts until students earn their degrees. We empower first-generation, low-income college students to live lives of choice and opportunity through:

ACADEMICS: CB supports students in becoming competitive in the college application process and prepared for college-level work. Committed to improving GPA and ACT scores, CB emphasizes one-on-one tutoring, hosts math workshops/camps, and offers free college courses in math, sociology, and science.

MENTAL HEALTH SERVICES: CB removes behavioral health barriers that stand between students and college degree completion. Through therapy and social-emotional learning, CB provides timely interventions to strengthen coping and resiliency skills to help students meet their goals.

GRADUATE POSITIONING SYSTEM (GPS): CB guides students through the technical, often-frustrating college application process. Our students visit college campuses, meet with admissions representatives, and attend specialized workshops. Coaches guide students through the maze of financial aid and the often impenetrable language of higher education.

CAREER READINESS: College graduates earn more than 2.5 times that of high school graduates. It literally pays to go to college. CB coaches support collegians with resume assistance, connecting to internships and jobs, networking, and practice interviews. Degree in hand, CB students graduate prepared to join the St. Louis workforce and earn family-sustaining wages.

INNOVATION: We listen to our students, community partners, and peers and adjust to meet their needs. As the higher education landscape shifts, CB responds, creating new programs and fine-tuning existing ones.





academics

We recognize that access programs that don't include preparation for the rigors of college are addressing only a small aspect of a far greater problem.

Low-income, first- generation high school graduates from the St. Louis area who enroll in college tend to enter without the skills or support necessary to graduate. In 2018, we confirmed many CB students' significant lack of proficiency in math. 55% percent of CB students were performing below an 8th grade level as high school sophomores. While we knew our students' math proficiency was low, we were unaware of the seriousness of the problem.

Due in large part to these findings, 2018 saw the creation of a team at CB devoted solely to the academic development of our students. Led by Nikki DeLeo, a former St. Louis Public Schools Math Specialist and seasoned educator, CB's Academic Development team focuses on mastery of college standards in math, logic and writing.

This work is supported through robust annual academic assessments (beginning during sophomore orientation) and opportunities to earn college credit while attending high school.

CB was a pioneer in the college access and completion field when we added mental health services in 2012. Our goal is to provide timely interventions to strengthen coping and resiliency skills, thereby empowering students to realize academic success. Through annual behavioral health and trauma screenings, therapy from full-time CB staff, and case management for students accessing providers in the St. Louis community, CB is removing behavioral health barriers that stand between students and college degree completion. CB's layered approach ensures access for all students, at multiple points along the way. Our mental health programming is:

- asset-based
- focused on personal strengths and building skills to overcome weaknesses
- integrated throughout the CB curricula

In addition, our team provides short-term therapy for students who need additional assistance with communication, interpersonal relationship skills, stress management, and emotion regulation.

"Throughout school I had extreme emotional highs, and more extreme lows. The mental health team was always there for me and never made me feel like I was imposing. They challenged me to look deeper into critical moments in my development. These resources have been fundamental in breaking old patterns I needed to let go of. I cannot say for sure I would have grown into who I am today without them."

FIND YOUR WAY

graduate positioning system/gps

Low-income high school students are just as likely as their high-income peers to rate attendance at a four-year college as their top option following high school graduation, yet far fewer matriculate.

At College Bound, we know that these statistics have little to do with ability and much to do with journeying through uncharted territory. Our Graduate Positioning System (GPS) provides tools and support to help students navigate the complex, often concealed path to and through college.

Throughout high school, CB positions students for success in matriculating to college. From summer boot camp for rising seniors, where college lists are developed and personal statements fine-tuned, to twice weekly fall workshops where coaches provide application assistance, CB guides students through the college search and application process. We also meet with each family to complete the FAFSA (Free Application for Federal Student Aid) and help during the complicated financial aid verification process.

Well beyond the paperwork, our coaches arrange campus tours, provide opportunities for admissions representatives to visit and meet students in St. Louis, and advocate for students every step of the way. After the acceptance letters arrive, our college counseling team meets with students and their families to offer guidance in the selection process and assistance with some of the more nuanced tasks that are required prior to the first day of class. College Bound's GPS sets students on a path to success.

"Being admitted to MSU really helped me overcome a lot of personal fear I had of not being able to get into college, because no one in my family has made it. Going forward, I have been more confident in the application process and have been able to show my younger siblings that college can be in their future."

careerreadiness

Education pays. College graduates earn more than 2.5 times that of their peers with high school degrees or GEDs. But the shift from college to the workforce is not intuitive and the skills and experiences necessary secure a job and earn family-sustaining wages are not always clear.

To ease the transition, CB supports collegians with:

- Resume assistance
- Internship and job connections
- Field-specific networking opportunities
- Practice interviews

culture of innovation

We are often asked about expanding our reach, especially as the need for degreed professionals—and the costs of college—climb higher and higher. CB is innovating to expand our expertise to a new population of students.

In 2017, in partnership with St. Louis Community College (STLCC) and the St. Louis Public Schools, we began serving students through a pilot program at STLCC—Forest Park. We served over 150 first-time college students in the 2018-19 school year and are on track to serve even more in the 2019-20 school year.

What's different about CB @ STLCC? Students join us as they start their college careers. What's the same? Everything else. They have access to our mental health services, one-on-one coaching, and path-to-degree planning. We're excited to see where year three leads!


measuring impact

HIGH SCHOOL GRADUATION

A high school diploma is the first step towards college graduation. CB students make a commitment to academics, taking AP courses, earning college credit while still in high school, and spending summers at our math camp and CB Summer Institute. The results of their hard work are clear.



Matriculation to a four-year college is a hurdle for first-generation college students. To get there, students have to navigate the funding and financial aid process and secure safe, affordable housing, among many other tasks. 97% percent of students in the CB Class of 2018 matriculated to college within six months of high school graduation.



COLLEGE GRADUATION

While degree attainment has increased dramatically in recent decades, the graduation rate for low-income students of color has remained stagnant. Finances, navigating complex university systems, and not having someone who's done it all before as your guide all stand in the way. As a result, only 10% of low-income, first-generation students will graduate within six years. College Bound's long-term, one-on-one coaching model has leveled the playing field. 57% of CB students from the class of 2012 graduated within six years, which is in line with the national six-year graduation rate across all income levels.
